The final regional event of the year is the **South West Regional Sprint** event held at the end of June at Gloucester pool, 7 swimmers had a successful day. All swimmers set personal bests in all events.

Chippenham ASC competed in both the winter and summer Moonraker leagues, finishing 6<sup>th</sup> and retaining our position in Division 1 in the Winter league. In the summer league we finished 4<sup>th</sup> in Division 1 facing tough competition from the 3 top clubs in Wiltshire. There were some good individual swims throughout the galas with younger swimmers swimming well in what for some was their first gala.

## **5. Treasurer's Report**

Gary was unable to attend the AGM, but sent his report which showed the club had made a healthy profit of £11,000 this year. It was proposed that the club's annual membership fee remain at £40 single £80 family membership. The club is due to spend money on training and on purchasing new drogues. A number of the Committee have worked hard this year to make sure that parents are paying the correct amount for

session fees. The profit made would provide a useful "buffer" and allow for any increase in pool hire this year.

Denise pointed out that the club's printer should no longer be listed as a "fixed asset." The printer is only used for club championships.

There are no more Level 1 courses available at the moment. Nigel pointed out that the Level 3 courses may be changing this year.
